## 1. The Centre

---

The Social Policy Research Centre (SPRC or the Centre) conducts research, provides higher-degree research training, and fosters discussion of the nature and consequences of social policy and of the social needs and processes which give rise to it. The SPRC undertakes research across a wide range of social policy topics, taking a variety of approaches which are organised into three fields of research and three methodologies. The three fields of research are: poverty, inequality and social inclusion/exclusion; communities, families and care through the life course; and the organisation and delivery of human services. The three methodologies or approaches are: comparative social policy (with a focus on the Asia-Pacific region); community service outcomes and evaluations; and analysis of policy and societal trends.

The Centre was established in 1980 under an agreement between the Commonwealth Government (through the then Department of Social Security) and the University of New South Wales. The initial five-year agreement was extended in 1985, 1990 and 1995 before being terminated in 2000. The Centre currently attracts funding from a range of sources including Commonwealth and State government departments; research funding bodies such as the Australian Research Council; international funding agencies; and a variety of Australian and international non-government organisations. Financial and in-kind support is also provided by the University of New South Wales; the Centre is located in the Faculty of Arts and Social Sciences (FASS).

### Higher Degree Research Program

The SPRC provides interdisciplinary PhD training in social policy in a stimulating and supportive environment. The SPRC offers a unique opportunity for higher degree by research study at PhD and Masters by Research in areas that explore and extend the theory and practice of social policy in Australia and internationally. In 2011 the centre had 26 higher degree research students.

### Events Program

The SPRC hosted the 12th Australian Social Policy Conference, Social Policy in a Complex World, from 6-8 July 2011. The Conference program included the Second Chinese Social Policy Conference and for the first time a Higher Degree Research Workshop.

The Conference was officially opened by Professor James Donald, Dean Faculty of Arts and Social Science, and Commissioner Alison McClelland, of the Australian Government Productivity Commission. The plenary speakers were **Professor Paula England**, Professor of Sociology, Stanford University USA; **Professor Bea Cantillon**, Professor of Social Policy and Director of the Centre for Social Policy, University of Antwerp, Belgium; and **Professor John Quiggin**, Australian Research Council Federation Fellow in Economics and Political Science, University of Queensland.

A total of 152 papers were presented at the conference from a wide variety of presenters, dealing with the key issues in Australian social policy.

The SPRC is looking forward to the next Australian Social Policy Conference to be held in 2013.

In addition to the conference, the Centre once again ran a successful seminar program. There were 14 seminars during the year, a number of which were collaborations. The 2011 Seminar Program was jointly organised by Roger Patulny and Melissa Wong.

In April 2011 the Centre hosted a workshop on “The Wellbeing of Children in Australia” that brought together Australian and international experts working on these issues with policy makers and advocacy groups. The workshop presented results from two Australian Research Council funded projects at the University of New South Wales, the first on ‘Comparing the living standards of children and older people within and between nations’, and the second on ‘Supporting families: Horizontal and vertical equity in the Australian tax-benefit system in historical and comparative perspectives’.

In October 2011, the Centre co-hosted a workshop on “Emotions in social life: New advances in sociological and policy research”. This one-day workshop was co-hosted with the Department of Sociology and Social Policy, University of Sydney. The workshop brought together leading Australian researchers to present and discuss their research on the interconnections between emotionality, social theory and policy, and was successful in improving the visibility of sociological research on emotions within Australia.

### **Staff Achievements**

Professor Deborah Brennan was appointed to the NSW Government Review of funding for early childhood education.

Professor Peter Whiteford was an invited participant to the Commonwealth Government’s Tax Forum held in Canberra on 4-5 October 2011.
